2. Discussion & Action:

a. Discussion of Board of Supervisors Dissolution of the Commission for Women

I met with Linda Parks (July 31, 2013 at 2 p.m.). We had a nice long talk. She said that the Commission for Women will be dissolved this coming Tuesday at the Board of Supervisors meeting in Ventura. In its place they are proposing to start the "Women's Economic Roundtable" to address career choices/opportunities and pay inequities. They will not do studies (needs assessments) but rather conferences every two years. They will seek women's groups buy-in through their recommendations for appointments to this new organization. They are proposing a 10 Membership group with 2 appointees from each Supervisor, residency will not matter. Funding may be available through Linda Parks and Kathy Long but this probably hasn't been thought out. They think in may not be needed as they may seek funding through sponsors, etc. like the Senior Conference they hold. Linda attended the National Business Women Owners Conference recently and believes such organizations could support it as well as the Chamber of Commerce, Universities, Workforce Investment Board, and local women's organizations. After the Tuesday event, Linda proposed that a luncheon will be arranged if VCCW Chair Kitty Dill thinks it is appropriate, and certificates of appreciation and expressions of thanks and goodbyes will be the agenda at that time. The Brown Act will not be affecting that meeting Linda said. My thought is this: The Commission for Women was set up to advise the BoS and its advice is no longer of interest to them. If there was a desire to continue the Commission it would have to become a non-profit. This new organization, WER, sounds similar to the Ventura County Women's Forum Collaborative which is a non-profit. The manner in which this is being undertaken is aggressive to limit the negative impact on the BoS I believe, and to limit any "picketing". Also the BoS has not been happy with VCCW, the study as only "received and files",

and their appointees have all given them negative reports on VCCW so this is one way to address the "problem".

My recommendation is that we have a meeting on Saturday after 3 pm (I have a class 8-3pm on that day) and finish all of our business - final reports and recommendations if possible. PS. Linda wanted to send Certificates of Appreciation and a letter to all Commissioners but found out the Brown Act prevents her from doing this (she called later and told me this). Meeting Agenda possibilities: NACW Resolutions to approve and recommend to the BoS; Final Annual Report 2011-13; Plans for following up on the distribution of the study; Final letter to the BoS and any recommendations on the new direction.

These are my thoughts right now:

- 1. The Board of Supervisors is difficult to work with, and they have not provided directions as to how to improve working with them. Supervisor Zaragoza as Board Chair was the most helpful in 2011 (the agendizing and resultant ratification of the Study and funding). There has been no response to Debra's letter to the BoS explaining problems. The BoS has responded to our current letter by ending VCCW, but without a direct response to the letter. We never had our Study Session.
- 2. The CEO analysis was to study us, met with us, attended our meetings, but we have not seen her report. It must have been a negative report as it may have justified the dissolution of VCCW.
- 3. When Commissioners resigned they gave disgruntled reports to their Supervisors. These supervisors never requested a response from us. In fact, we were never notified that these people resigned. (This was to be corrected by proposed Policies & Procedures)
- 4. The VCCW Commissioners have been working to address the problems that we have identified in hopes of making the Commission better and improving our working relationship with each other. All this we have done without a response or help from the Supervisors (in that process one Supervisor suggested we write our Policies & Procedures, which we did draft), but just the exercise of their power to not appoint any new commissioners, a slow death process (3 vacancies in both Bennett, Long districts; one vacancy in Parks district although I had been told they were appointing someone, but not who; Zaragoza's non attending representative). The message is clear that they do not want to give us more time to straighten this out. Nor do they trust us to do it.
- 5. Problems or issues I believe are concerns of the BoS: (Details are not described here, but Commissioners know the detail, and the pain all of this has caused us.)
- * Status on Women & Girls a needs assessment with recommendations that overstepped jurisdictions
 - * Negative resignations from appointees
- * Women's Forum Collaborative not becoming part of VCCW A major problem for VCCW was naming it a "Collaborative" and then trying to claim ownership.
 - * The VCCW funding from 3 grants and ticket sales
 - * The Petty Cash Bank Account instituted years before any of us were even appointed.
- * No direction from BoS/County on how to approach them to obtain their advice, direction &/or approval for the purposes described in the VCCW bylaws; and no response when we tried. Example: Last approved bylaws were 1998 according to the CEO analyst.
- 6. Commissioners have often felt the Commission was at the bottom of the totem pole as far as BoS thoughts are, but it was at the top of Commissioners "totem pole", that is it was high in our priority. We were there because of our belief that a Commission for Women is important to bring to the BoS the issues in the community as seen by the people in it. There are over 300 people the Supervisors appoint to serve in different organizations hoping as we do to make the County a better place, to make a difference. To help the Supervisors to do their job. I thought one person who did that for 17 years deserved a letter/certificate at her retirement from her Supervisor. Perhaps we are waiting for that "Hell Freezes Over" event.
- 7. The two Supervisors who are proposing to sunset the VCCW and sunrise the WER are willing to give it all the support it needs, and if the women's organizations will support it also then it will be successful for a time and welcomed. But, all Diana's concerns are justified and should be heard by the BoS and community.

 Those are my thoughts.
