# Women's History award honors Erica Neville

She was a young housewife and mother, a dedicated community activist and a returning student working toward a degree in education when she died suddenly on Jan. 27, 1986. Among the many people stunned by her loss were the women who served with her on the Women's History Project of Ventura County.

As word of her death spread, many of us dealt with our grief by sharing memories of Erica. There was the trip to Chicago in May 1980 for a "Mother's Day March for the E.R.A." and a weekend of volunteer effort for ratification by the State of Illinois. At the rally after the march, Erica had had an epileptic seizure, but quickly recovered and rejoined our group.

During 1981 she first heard about the National Women's History Project and enthusiastically joined in plans to celebrate March 7–13, 1982 as Women's History Week. Erica coordinated the highly successful effort to have women and women's organizations donate books about women to the Ventura County Library Services Agency. She also scheduled showings for the film "How We Won the Vote" at four different libraries around the county.

A handmade quilt with a needlework patch for each of the 35 states which ratified the Equal Rights Amendment also received Erica's time and energy that same year. It was a project of Simi/Conejo N.O.W. (National Organization for Women) and was displayed at the Thousand Oaks Library during Women's History Week.

In January, 1982 Erica dressed as Alice Paul, a suffragette leader who wrote the original text of the E.R.A., and did a program about her for the Women's Equity Coalition. This experience encouraged her to prepare classroom presentations for different grade levels and begin visiting

Conejo Valley elementary schools during Women's History Weeks in 1983, 1984, and 1985. Dressed as a suffragette, or as Alice Paul specifically, or as a pioneer woman coming west, Erica would delight students and teachers and give meaning to the week's observances.

On March 6, 1986 at a special luncheon in Camarillo, the first Alice Paul Award was presented to Erica's mother and son to honor her. On March 7, 1987 this award will be given to one educator and one community activist in recognition of their efforts to follow Erica's model in promoting Women's History Month in Ventura County.

# Positive Parenting Foundation offers choices to new parents

Last year, nearly 2,000 babies were born in the Conejo Valley. Because the transition to parenthood is the single most significant and permanent change in a person's life, the Positive Parenting Foundation was established to aid in that transition.

The non-profit network provides education, support, referrals, and resources to new and expectant parents in the community. The goals are two-fold: to make parenting as rewarding an experience as possible and to improve the quality and availability of day care in the community by establishing new centers and employer-sponsored day care.

Proceeds go to the Women's History Project of Ventura County to support continuing women's history activities.



The author is the NOW Legal Defense and Education Fund and Dr. Renee Cherow-O'Leary, professor of communications and public policy at City University, New York.


Available Nov. 24, the McGraw-Hill publication is available in paperback for \$12.95 or in hardcover for \$19.95.
