Commission to hold forum on Women in Agriculture



he unique problems of women in agriculture in Ventura County will be the focus of an all-day workshop sponsored this month by the Education Task Force of the Ventura County Commission for Women.

The Commission's first educational workshop will be held from 10 a.m. to 3 p.m. Saturday, May 31 in the U-V Building at Ventura College. The public forum will focus on women in agriculture in the county.

The main goal of the forum is to increase public awareness and the visibility of women in agriculture. Issues to be addressed include the history of women agricultural workers in Ventura County, hiring practices, job retraining needs, fundings for such retraining, the effect of pesticides on agricultural workers, and the special problems created by cyclical employment.

The forum will consist of a panel of speakers who will address the audience as a whole, and will also employ the use of small roundtable discussion groups in which the entire audience may participate. Speakers are expected to represent a broad spectrum of interests and expertise in the area of agriculture and/or women. English/Spanish translators will be provided.

Participants are encouraged to bring a sack lunch, although there are many restaurants in the immediate vicinity of the college campus.

Task force report: comparable worth

The California Comparable Worth Task Force completed its operations last year and submitted its final report to the legislature. Established in 1983 by a joint legislative resolution (ACR-37, Tanner), the task force was created to propose and evaluate solutions to remedy pay inequities for California's women workers. The report contains an overview of sexbased discrimination in the workforce and includes findings and recommendations regarding the implementation of comparable worth in California's public (state and local) and private sectors. A limited number of copies of this report are available from the office of the Ventura County Commission for Women.

"SALUTE TO WOMEN" AWARDS

The Ventura County Commission for Women is pleased to open nominations for the fifth annual "Salute To Women" Awards. The Commission will recognize up to fourteen women, each of whom has made an outstanding contribution to improving the quality of life here in Ventura County. The woman selected in each category will be honored by the Commission, Friends of the Commission, community members and personal guests at a banquet to be held on October 29, 1986.

The nomination form itself is a reflection of the candidate being proposed. The manner in which you complete it, therefore, can either help or hinder your nominee's chances of being selected for an award. Follow directions carefully. Type or print neatly in ink, and give careful consideration to the letter you attach.

Remember that many outstanding women are nominated for these awards; the letter of recommendation should outline why this nominee should be singled out for special recognition. Explain, in concrete terms, what your nominee has done to better the status of women and/or to benefit the community. Note active membership in local organizations and include any positions held. Consider leadership characteristics and community experience (both past and present). How many people have been impacted by your nominee's work? Why is her work or contributions of particular significance? Determine the depth and span of her contribution in terms of time and degree of commitment. Finally, assess the degree of challenge your nominee faced in successfully accomplishing her goals and how she overcame that challenge. Any additional information you can provide – such as nominee's age, cultural background, disabilities, etc. – would be appreciated.

Attach your letter to the completed nomination form and mail to the Ventura County Commission for Women at the above address. All forms must be received or postmarked no later than June 15, 1986. Please note that current Commissioners and board members serving the Friends of the Commission are not eligible for these awards. Also note that awards are given at the discretion of the Commission Selection Committee and may not necessarily be granted in every category.

We thank you for your participation in the "Salute To Women" Awards and for your continued support of the Commission. The Commission exists for us all and the Awards are, in fact, a salute to all the women of Ventura County who contribute so much and so well.
