
FIRST SYMPOSIUM ON CHILD CARE SLATED MAY 19, IN THOUSAND OAKS

"Working Parents: An Employers' Symposium on Child Care" -- the first such conference to be held in Ventura County is being launched by the Ventura County Commission for Women.

Scheduled for Thursday, May 19, at the Hungry Tiger Restaurant in Thousand Oaks, he purpose of the symposium, according to Commissioner Carol Keochekian, symposium chair, is to provide employers with information and to raise awareness as to how business is becoming more involved with child care. "To assure that we will be presenting the kind of information employers want to know," the chair concluded, "we have brought together a very astute group of industry representatives to plan the program for the half day event."

DR. MARJORIE BELL CHAMBERS TO SPEAK ON MARCH 12

"Women's Heritage, Women's Hopes," will be the topic to be presented by Dr. Marjorie Bell Chambers, feminist, political activist and contemporary historian, at "Creative Options: A Day for Women" on Saturday, March 12. Sponsored by California Lutheran College and AAUW of Thousand Oaks, the event will be held at Cal Lutheran from 9 a.m. to 4 p.m. for all interested women.

Her topic will include a consideration of women's shared history and a discussion of the 1980's as a time of new opportunity for women, especially in education. In other words, the question she will address is, "Where have women been and where are we going?" She will also present a workshop entitled, "Where Have All the Women Been in American History?"

A pressing need in Ventura County is a lack of space in alcoholic treatment centers for women alcoholics, the Ventura County Commission for Women was told recently.

Deborah Smith, representing the Women's Commission on Alcoholism for the State of California, said in Ventura County, women's residential beds are still very unrepresented (10 percent or lower). She pointed out the following facts on alcoholism:


Alcoholism is a disease, and is not curable, but is treatable. Women alcoholics make up 35-50 percent of the alcoholic population. All original studies on alcoholism have been done on men. Male indicators are inaccurate for women. Studies show women do very well in treatment.

Women's only programs are always full with waiting lists. Most alcoholic programs, she said, are based on the male model. She also noted that less than one percent of alcohol programs provide any kind of child care, at least 70 percent of alcoholic women have been sexually abused, and women face open opposition to get treatment for alcohol.

The Commission on Alcoholism, a private, non-profit organization serving the state, is in its 8th year of existence. About 88 percent of those using alcoholism treatment facilities today, she pointed out, are white men. Only 11 percent of those in treatment are women. Today, organizations in existence are California to raise awareness of this issue women and alcoholism. The state Commission, with a statewide board of directors, is presently working to improve the quality of facilities which already exist.

Rainbow House, an alcoholic recovery home for women in Ventura, also appeared at the meeting to seek Commission support for women's alcoholism programs throughout Ventura County.

Judy Christensen, Rainbow House representative, reported that the house has been fixed up nicely. Officially opened on Dec. 5, 1982, the home has served 15 women, mostly young, in their 20's, who are doing well. Highly commended by the state inspector, the home has closed down for two weeks for paperwork and recertification.



MEET YOUR COMMISSIONERS: LAUREN ANDERSON

When asked her reason for wanting to become a member of the Ventura County Commission for Women, she replied: "To help the women of TODAY, who in turn will be of help to our women of TOMORROW."

A resident of Ventura, Mrs. Anderson represents Susan Lacey's Supervisorial District I. A native of Los Angeles, she grew up in Southern California, graduating from Thousand Oaks High School. She received her AA degree in business from Pierce College.

She and her husband Jack have two children, Dan, 15, and Neil, 13. She enjoys cooking, reading and spoiling the two family dogs. She takes aerobic dance and rides a bicycle five days a week.

Currently employed as senior secretary for the Director of Business Planning at Vetco Offshore, Inc., Ventura, she finds her job extremely challenging. In the past, shas served as a member of the Ventura County Hotline and the Ventura County District Attorney's Victim/Witness Program. Currently, she is an active member of the Ventura Business and Professional Women's Club. Pledging to see that the California mission on the Status of Women "not only survives, but becomes even stronger and more vocal," Southern California attorney Hannah Beth Jackson was elected chair of the California Commission on the Status of Women on Friday, September 24, at a Commission meeting in San Francisco.

Also elected as Commission officers for the 1982-83 fiscal year were Dorothy Janas of Los Angeles, vice-chair; Linda Kasem of Beverly Hills, secretary; Carole Ward-Allen of Oakland, executive officer at-large; and Gloria Godell, Los Angeles, fiscal liaison.

Appointed to the Commission by Governor Brown in 1978, Jackson is a partner in the law firm of Eskin and Jackson of Santa Monica and Ventura. Formerly a deputy district attorney for Santa Barbara County, she went into private practice in 1977 specializing in civil litigation, real estate and family law. She is a member of California State Bar, the bar associations of Beverly Hills, Ventura County, and Los Angeles County. ongs to California Women Lawyers, Women Lawyers Association of Los Angeles, the Ventura County Women's Lawyers Association, the National Women's Political Caucus, and the American Civil Liberties Union.

Jackson also chairs the Commission's Child Support/Child Custody Advisory Committee. A graduate of Scripps College in Claremont, she earned her J.D. degree at the Boston University School of Law.

She succeeds Irene Hirano of Los Angeles as chair. Hirano, the executive director of a women's health clinic, served the maximum two one-year terms permitted under Commission by-laws.

It is clear that, of all problems facing women, the economic issues are the most pressing. As programs and funding designed to assist women in achieving economic viability are reduced or the cuts in AFDC, social security, Medi-Cal health care, as well as child support, child custody and ld care.

My fellow commissioners and I see the following as other critical areas in need of change:



...Increase the Commission's support network with local commissions and other women's organizations to share data and projects, and create (where possible) a louder and stronger voice.

...Focus on the needs of minority women, and thereby broaden the reach and effectiveness of our programs.

...Explore proposals for expanding child care services, including the development of innovative programs not dependent on federal funding.

...Educate homemakers, the most underpaid and underprotected of all women workers, about their rights and legal status.

...Seek legislation to correct the inadequacies and injustices in California's child support laws, which provide too little to too few and are far too costly to enforce -- a problem I see daily in my law practice.

...Explore the problems of child sexual abuse and incest, the crimes that never happen to anyone we know but, according to FBI statistics, are committed upon an estimated 25% of all female children.

It is our hope that in the next year we will find new ways of working with groups already involved with these issues.
