A regular meeting of the Ventura County Commission for Women was held in the Commission office at the Human Services Agency, 4601 Telephone Road, Suite 117, Ventura, on Saturday, March 3, 2007. As the Chair was not present the Vice Chair called the meeting to order at 9:17 a.m.; the secretary was present.

Present were Vice Chair Mary Pallant, Correspondence Secretary Debbi Steele, Recording Secretary Lee Riggan, Past Chair Diana Goodrow, and members Sharon Hillbrant, Elvia Guizar, Jan Lawrence, Shoshana Bower and Ruth Ann McAllister. The Chair, Nancy Lee Phillips, arrived after the Call To Order.

The Vice Chair read the VCCW Mission Statement.

By general consensus the agenda was adopted as presented. There was no public comment.

By general consensus and after discussion the minutes were approved as corrected.

The Vice Chair reported that there was no change in the VCCW bank balance of \$497.53. Two bills were presented for payment having been approved at the February meeting, \$100 to the Women's Economic Ventures Project, and the mileage for the representative, Diana Goodrow, to the meeting of the Association of California Commissions for Women (ACCW).

Correspondence Secretary Debbi Steele reported on correspondence received and her use of the email to update correspondees on the VCCW address change.

After much discussion Elvia Guizar volunteered to take initial steps to work toward updating the VCCW website hosted by Ventura County.

Jan Lawrence and Mary Pallant reported on the Women's History Project. VCCW will receive a Proclamation acknowledging women's contributions on Tuesday, March 6, 2007 at 9:30 a.m. from the Ventura County Board of Supervisors. Members are requested to attend. Mary Pallant will provide the statement of appreciation. VCCW members will distribute questionnaires on Women in History to all libraries.

Application in Los Angeles. At the conclusion VCCW decided not to accept the direction of Community Partners. By general consensus it was approved that Elvia Guizar and Lee Riggan are directed to ask PYPF to consider a VCCW partnership on this project at their upcoming March 10th Board meeting.

Debbi Steele reported on behalf of the Women's Forum Luncheon Collaborative Committee (9 attendees) which met in February. The remaining Save-The-Date cards were distributed to members to send at their expense to their mail lists, names and addresses to be forwarded to Debbi Steele. A newsletter was prepared for bulk mailing March 19 after VCCF approval. The next meeting of the Committee will be March 15 at 6:30 p.m. at Coco's Restaurant in Camarillo. The "Forum Tool Kit & Report for the "ECONOMIC JUSTICE IN THE CHANGING GLOBAL ECONOMY" was completed.

After much discussion, based upon the precedence documented in a 1995 letter from the Commission that the VCCW has supported and endorsed the Ventura County Reproductive Rights Network (VCRRN) since its inception, by general consensus VCCW will continue to support this organization. However, members agreed that as a member organization it has the right to approve, prior to issuance, correspondence and publications using the VCCW logo. The Association of California Commissions for Women (ACCW) will also continue to be supported.

Shoshana Brower reported that the Cal WORKs Mentoring "Friends of CW United for Success" training will take place in May. She will report to Lauri Flack that VCCW members Jan Lawrence, Elvia Guizar, Ruth Ann McAllister, Mary Pallant, Diana Goodrow, and Shoshana Brower volunteered to serve as Mentors.
